CERTIFICATE OF APPROVAL AND FILING OF AMENDMENT TO THE
DECLARATION FOR THE CREATION AND ESTABLISHMENT OF
VILLAGE ON THE GREEN CONDOMINIUM I

On April 10, 2012, a meeting was held of the Board of Directors and Association of VILLAGE ON THE GREEN CONDOMINIUM I, a Florida Corporation, and with not less than sixty-six and two thirds (66 2/3%) percent of the voting members duly qualified to vote, by these presents and by separate written instruments which are maintained in the official records of the before-mentioned corporation and which are incorporated herein by reference, does hereby amend the Declaration for the Creation and Establishment of Village on The Green Condominium I which was recorded in O. R Book 4736, Page 1320, et seq., and Condominium Plat Book 29, Pages 97 through 102, in the Public Records of Pinellas County, Florida, and pursuant to the provisions of Article X, Section 1, does hereby file this Amendment to the DECLARATION FOR THE CREATION AND ESTABLISHMENT OF VILLAGE ON THE GREEN CONDOMINIUM I:

**Article XVIII, Section 4 to be amended as follows:
Delete entire section and substitute:**

No pets of any kind shall be permitted in any Units or in the Common Elements or Limited Common Elements except for one (1) domestic indoor cat and birds, such as canaries or parakeets, and fish, such as goldfish or tropical varieties, which may be kept by Unit Owner in his/her respective Unit provided that no such animals shall be raised for commercial purposes or shall constitute a nuisance to other Unit Owners.

THIS AMENDMENT TO THE DECLARATION FOR THE CREATION AND ESTABLISHMENT OF VILLAGE ON THE GREEN CONDOMINIUM I is made this 17th day of April, 2012.
